




Pillar one - Communications






Pillar two - Collaboration






Pillar three – Legislation change





Provision Definition Documents

The provision definition documents (PDDs) that define the provisions of the PSPJOA for each area of the 2015 Remedy are now being finalised and will inform the retrospective secondary legislation

Central PDDs developed by HMT/ Responsible authorities via cross-Whitehall working group

The Home Office is engaging informally with the SAB on scheme specific policy – joint sessions with Fire and Police – ahead of formal consultation early 2023

Consultation now expected to start 23 January 2023 for 12 weeks
